## How to Pay Your Property Tax Online Via Electronic Check A Step-by-Step Guide

**STEP ONE:** Proceed to <http://prop-tax.countyofventura.org/> and search for your property by parcel number or address and click **"SUBMIT SEARCH"** When searching by parcel number do not included dashes.
